17	NOT IN COMPLIANCE; CORRECTED DURING INSPECTION 3-403.11; Reheated foods have to be heated to 165 degrees within 2 hours. Queso and Chili were found in the hot holding wells at 115 and 102 degrees. CDI by PIC who heated up to 165 degrees by the 2 hour mark. Recommendation is to not heat up in the hot holding wells. Heat up on the stove or in another way to meet temperature requirements. No points taken
