CDI by PIC who threw away cracked eggs and milk being stored in the cooler out. Those itmes were the only things in the cooler considered potentially hazardous.
41	NOT IN COMPLIANCE; CORRECTED DURING INSPECTION 3-304-12; In use utensils shall be stored as to not contaminate the food. The handles of scoops were found to be in the sugar and flour CDI by PIC. No points taken as all other utensils were stored properly
